Director Yates moved that the Board open the Public Hearing to discuss the proposed Budget Amendment. Upon a second by Director Dillman, the Public Hearing was opened. There was no public comment. Director Yates moved that the Board close the Public Hearing. Upon a second by Director Dillman, the Public Hearing was closed. Director Yates moved that the Board approve and accept the 2022 Budget Amendment for the Independence Metropolitan District #1, as
